Fourth Meeting of Taskforce Held



Fourth meeting of the Taskforce on Policy and Strategy of ICZMP was held on 6 April 2005 at the meeting room of the Ministry of Water Resources. Chaired by the Secretary of the Ministry Mr. Abdul Aziz ndc, the meeting was attended by officials of the Ministries of Water Resources, Fisheries & Livestock, Land, Food & Disaster Management and Environment & Forest, as well as officials of the Planning Commission, WARPO, PDO-ICZMP and CARDMA. Participants discussed about the proposed Program Coordination Unit for institutional arrangement for coastal development and selected Bhola and Cox's Bazar for preparing district development plan.

Draft CDS Presented to Members of Parliament



The draft coastal development strategy (CDS) was presented on 9 July to the Members of the Parliament representing the coastal zone. Deputy Speaker of the Parliament Mr. Akhter Hamid Siddiqui chaired the meeting, while Water Resources Minister Mr. Hafizuddin Ahmed Bir Bikram attended as the chief guest. Among the participants were Barrister Moudud Ahmed and Barrister Mohammad Shajahan Omar Bir Uttam, Minister and State Minister respectively of the Ministry of Law, Justice & Parliamentary Affairs, State Minister for Finance and Planning Mr. Shah Mohammad Abul Hossain and Members of the Parliament Mr. Panchanan Biswas, Mr. Zainul Abedin Faruk, Mr. Syed Shahidul Hoq Jamal, Mr. Sarwar Jamal Nizam, Mr. Md. Shahiduzzaman, Mr. Mosharraf Hossain Mongu, Mr. Shah Md. Ruhul Quddus, Mr. M M Amin Uddin, Mr. A M Riasat Ali Biswas, Mr. Gazi Nazrul Islam, Mr. Zahiruddin Swapan, Mr. Abul Hossain Khan and Mr. Md. Shahiduzzaman. Participants emphasized the need for better coastal zone management, prioritization of



investment programs, involvement of people's representatives in planning & monitoring, ensuring transparency and accountability, formation of a coastal development board and increased budgetary allocation for the coastal zone. WARPO, PDO-ICZMP and CARDMA jointly organized the meeting.

District and Local Level Consultations on Draft Coastal Development Strategy

In March 2005, 28 consultations on the draft coastal development strategy (CDS) were held at different locations of the coastal zone: three islands, three unions, three upazilas and 19 districts. Consultation meetings were organized by the district administration and facilitied by local NGOs. Among the participants were government officials, local government leaders, representatives of NGOs, CBOs, private sector and the civil society. Participants prepared priority list of development interventions for respective areas. According to participants, such consultations on a national strategy document have been held for the first time in these islands. Participants demanded special allocations from the government for implementation of this strategy. Selected expressions of 'hopes and concerns' are mentioned below.

Consultation on Local Institutional Environment for Coastal Development



Daylong consultations were held in different coastal locations participated by representatives of different social classes. Under this program, consultations were held at union, upazila and district levels in nine districts, such as, Cox's Bazar, Chittagong, Noakhali, Bhola, Patuakhali, Barguna, Bagerhat, Khulna and Satkhira. Main agenda of the consultations is to discuss and identify local level institutional arrangement for coastal

development. Participants laid emphasis on strong local government including the Union Parishad. The series of consultations began on 13 March at Kutubdia and ended on 25 June in Chittagong. Bangladesh Institute of Development Studies (BIDS) is implementing the program. Divisional level

consultations will be organized at Chittagong, Barisal and Khulna

and a national consultation in Dhaka.

Integrated Coastal Resource Database : Being Developed

implementing the component with support from the Institute of Water Modeling (IWM) and the Centre for National Resources Studies (CNRS).

Activities include developing an Integrated Coastal Resources Database (ICRD), a study on climate change, a 'future scenario' analysis, ground truthing of islands and chars, district development plans for Bhola and Cox's Bazar and support to agencies to prepare concept notes for priority investment program (PIP).

Under the ICRD, a database has been designed including a meta database and tool box (home page in picture). Collection & collation of data from 10 organizations have been completed. New hard and softwares were purchased and being installed Operationlization of ICRD database with supporting tools and establishing operational links with The CNRS is assisting in other project databases like CDSP, CERP are being attempted.

Contacts have been established with 18 agencies for preparing concept notes for PIP. Separate working group for each concept note, comprising representatives from more than one agency are working. Participants (seen in the photograph) of the workgroup contribute in formulation of the concept notes work.

CEGIS, Center for Environmental & detailing components, cost, duration Geographic Information Services, is and institutional set-up of the proposed project.

> An inventory of chars & islands is being made with identification of 77 offshore islands. A draft report is expected by July 2005.

> Another report on future scenarios is under preparation that would include on population. scenarios investment and employment, changes in different sectors of the economy. A report is expected by July, 2005.

The IWM is assisting in the study on climate change. Link has already been established with NAPA (National Adaptation Plan of Action). The study will develop scenarios for the years 2015, 2030, 2050 and 2100. Model runs have been completed.

St. Martin's is a small island forming the southernmost part of Bangladesh. Fishing is the main livelihood of >5000 people living in this island. St. Martin's is a declared ECA (Ecologically Critically Area). It is one of the top tourist destinations of the country. It is the only coral bearing island and hotspot of rich biodiversity.

The PDO-ICZMP, jointly with the Dept. of Fisheries, organized a round-table & follow-up discussions on sustainable management of St. Martin's Island on March 31 and April 4, 2005 respectively. A total of 31 participants representing ministries and agencies (MoWR, DoF, FD, BPC, DoE, WARPO), Projects (ECFC, CWBMP, St. Martin's Project), Universities (DU, CU) and NGOs (CNRS, IUCN) attended the round table. Participants stressed the need for developing a Master Plan based on 1997 management plan with an aim to develop into a demonstrable model for ICZM.



Lecture Series : SPARRSO Presents

A discussion under the Lecture Series of ICZMP was held at the PDO meeting room on 25 May. Dr. MA Shahid, Principal Scientific Officer of SPARRSO, was the main speaker. He made a presentation using satellite images on changing landscape in the coastal zone as a result of shrimp culture. Academics and experts of the Dhaka University, University of Asia-Pacific, SPARRSO, WARPO, TARA and PDO-ICZMP participated in the discussion.
