## Bangladesh Weather and Climate Services Regional Project (BWCSRP)

## Disclosure of Social Impact Screening for 276 Automatic Ground Water Station at 69 selected sites of Component - B Under package BWDB-W2

The government of Bangladesh is implementing the Weather and Climate Services Regional Project (BWCSRP) with IDA credit in order to strengthen Government of Bangladesh's capacity to deliver reliable weather, water and climate information services and improve access to such services by priority sectors and communities. The project comprises of three components. Out of three components BWDB is implementing Component –B. There are a number of packages under this component. The package no. BWDB – W2 contains 276 Automatic Ground Water Well at 69 selected sites in Bangladesh.

The installation of 276 Automatic Ground Water Station (AGWS) will be done on a very small area of land owned by BWDB. Different alternative sites were explored for selecting the most suitable sites for installation taking into account concerned social issues. It was observed from the screening that the installations will not require land acquisition, resettlement, relocation and will not have negative livelihood impacts. As all the construction/installation activities will be conducted on BWDB's own land. No negative impacts are expected. However, if any unexpected negative impacts are identified during implementation, project will take necessary steps to mitigate the impacts following the guidelines suggested in SMF and RPF. On the other hand, according to the local stakeholders' opinion, significant positive social and livelihood impacts are expected from the project as installation of the Automatic Ground Water Station (AGWS) will provide real time weather data which will help save lives and properties all over the country. Installation of the above will require only few labors which will not cause any labor influx and working conditions of the labors and safety measures will be ensured. No works will be done/is being done on indigenous people's land.

The disclosure contains assessment of social impact for supply and installation of 276 Automatic Ground Water Station (AGWS) at 69 selected sites and social impact screening worksheet.
